

Retirement Plans

Course Description

Lesson 1: Retirement Plans

1. Determine the differences between qualified and nonqualified deferred compensation plans identifying the tax advantages and disadvantages of each, the requirements of a qualified pension plan, and recognize how the basic ERISA provisions define the elements of qualified plans.
2. Identify types of defined contribution plans and defined benefit plans and their effect on retirement benefits.
3. Recognize the elements of Roth IRAs and traditional IRAs by specifying how distributions work, how to set up the various IRAs, utilize tax-free rollovers, designate beneficiaries, make distributions to beneficiaries, cite contribution limits for various IRAs, and determine how to recharacterize Roth IRA contributions.
